#### Memphis Area Transit Authority (MATA)

Effective through Thursday, April 30, 2020, all Memphis Transit Authority (MATA) fares are free to all customers and Sunday routes are in effect every day until further notice. MATA is continuing to operate its normal service at this time. Free fares will also help MATA to reinforce social distancing measures since passengers will be asked to board through the rear doors to limit direct contact with the operators.
